As part of its mission, OGE oversees and administers a financial disclosure system that reaches filers at 130 executive branch agencies government-wide. As such, OGE is the lead expert in the executive branch financial disclosure program.

In its oversight role over the executive branch financial disclosure program, OGE has been informally evaluating executive branch agency e-filing systems since 2006. In April 2012, OGE was specifically mandated by Section 11(b) of STOCK Act to develop an electronic public financial disclosure system for use in the executive branch. Drawing on its prior experiences with existing systems and taking into account efficiency and cost-effectiveness concerns, OGE is leveraging a government owned and operated solution to meet this STOCK Act e-filing development mandate.
