**Background:**

MIPIM (the French acronym for “the international market for real estate professionals and investors”) is a major real estate summit, held annually for the past 21 years in Cannes, France, bringing together from around the world developers, municipal governments, urban planners, landlords, investors, real estate service providers and “end-users” of global real estate.

This year, “end-users” are being offered free entry (€1,390 value) and 3 nights lodging (€209/night) to attend MIPIM World in March. As a major “end-user” of properties around the world, we have been offered the same travel-related “gift” as others, which is authorized in 2 FAM.

MIPIM is organized by Reed MIDEM of Reed Exhibitions based in France. They are not a trade organization or interest group with any business before the Department of State or USG as far as we are aware. They are simply an organizer of international trade and consumer events worldwide.

MIPIM’s 2009 attendance from 89 countries included:

- 29,000 participants including 532 “end-users”
- 2, 687 exhibiting companies, service providers, governments


